## Prepackaged Food Vendor Application

- Vendors must be licensed by the Oklahoma State Health Department.
- Vendor is responsible for collecting sales tax and remitting tax payment to the Oklahoma Tax Commission.
- The sale or consumption of intoxicating beverages is strictly prohibited.
- Vendor is responsible for providing tables, chairs, and extension cords.
- In the event of a booking duplication, applications will be honored in the order in which they were received.
- Electricity is included in the price of booth rental. Please note electrical service requirements on your application.
- Ice will be available on-site. Please order the amount of ice you will need and pre-pay with this application. The cost is \$3.00 per 25 lb. bag.
- There will be no rain dates or refunds.
- There is a \$25 refundable clean up fee. Funds will be returned within 1 month after festival if clean up is sufficient.
